WELCOME AND CALL TO ORDER at 7:48pm by O'Leary, seconded by Martin, and all in favor AGENDA APPROVAL

Motion to amend, with addition of New Business, **Item 9. Vote on DDA Mural Proposal**, by O'Leary, seconded by Carswell, and all in favor

REPORTS BY MAYOR, COUNCIL, CITY MANAGER AND STAFF

Councilmember Martin, Economic Development committee, stated that she has shown the potential lease spaces to many interested parties. The RFP period ends next week.

NEW BUSINESS

1. Audit Presentation

Rachel Miller, Alexander, Almand & Bangs accounting firm, reported that the 2022 Audit is complete and the opinion is positive. The City's position has grown through the year, with net income of \$7 million. Key factors in growth were LOST and impact fees. A draft copy of the audit was presented to Mayor & Council; the final version will be submitted to the state.

- 6. Water Connection Fees and Meter Cost Set-Aside
 City Manager Harrison explained that because of increased purchase costs of water
 meters, the portion of tap fees paid to the city by developers would be increased from
 \$350.00 to \$500.00
- 7. Resolution 2023-011: Mulberry Park

 To certify that the city has funds to cover its portion of expenses on the project; required to receive \$500,000 grant funding
- 8. Sign for New City Hall and Community Center *The city has received bids for \$10,750, \$15,000, and \$13,000*

CITIZEN INPUT

Mr. Rodney Cato, 140 Hawthorn Way, stated that street parking has become a problem; neighbors are parking on both sides of the street and ignoring HOA warnings.

Ms. Tina Brown, 205 Quail Run, urged the council to please make deliberate decisions.

Ms. Glenda Parkman, 71 Magnolia Cir, stated that some vehicles parked in driveways are covering the sidewalk, making it difficult/impossible to navigate with her daughter who uses a wheelchair. Ramps are sparse, so she must lift the wheelchair off the curb when these vehicles block the sidewalk.

Ms. Dee Poteet, 290 Chestnut Chase, stated that street parking is a big problem and makes it difficult for school buses, garbage trucks, and emergency vehicles to navigate the street. Vehicles hanging over the sidewalk when parked is another common problem. The city could refer to the city of Pendergrass parking ordinance 06-033 as an example.
