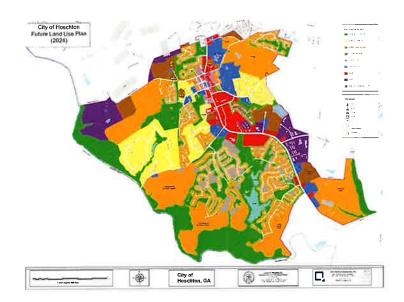
Initial Public Hearing
December 12, 2023 (City Council)

### Purpose

- An initial public hearing is required by state administrative rules
- Planning Commission held initial public hearing in November
- The purpose of this hearing is to brief the community on the process to be used to develop the comprehensive plan (5-year update), opportunities for public participation in development of the plan, and to obtain input on the proposed planning process
- Once public comments have been addressed, the community may begin the process of developing the plan

### What is a comprehensive plan? How used?

- A guide to future land use and capital budgeting decisions
- 20-year planning "horizon" with emphasis on next 5 years (visionary aspirational)
- Not a legal document not required to be followed (guide only)
- Vision, goals, and policies guide land use decisions (rezoning requests)
- Future land use plan also guides land use decisions
- Community work program (capital improvements, operating budgets and action items for the next 5 years)
- Hoschton is required to annually update its comprehensive plan because it collects development impact fees (for parks and open space land and police)

Community Work Program	Required (annually updated due to impact fees)	
Broadband Services Element	Required	
Capital Improvements Element	Required (annually updated due to impact fees)	
Economic Development Element	Not required	
Land Use Element	Required (future land use map and narrative)	
Transportation Element	Required (separate effort + coordination)	
Housing Element	Not required

### Process/ schedule summary (plan update)

- First step is initial public hearings (Nov. and Dec. 2024)
- A comprehensive plan steering committee has been appointed by city council and will meet 5-6 times (January May/June 2025)
- Various public participation efforts may be undertaken (summarized in later slide)
- Recommendations on the draft comprehensive plan will be made by the steering committee and planning commission (target June 2025)
- Review by the regional commission and state is required (60+ days)
- Adoption required by October 31, 2025 (qualified local govt. status)
