2. Darby Building Update

We still need to make contact with David Shepherd about availability of wood supply to repair the floor and ceiling. Further conversation should be had with the City Council regarding budget, potential relocation, and future use. If the Darby building is used as a museum, HPC members have a collection of items ready for display.

3. Mural Project Status

A meeting should be scheduled with the Arts Council to discuss the subject of the mural(s) and which company to employ.

4. Fundraising

- *Brick sales-Check with the DDA regarding location to use bricks...perhaps a walkway leading to the Darby building at Mulberry Park.*

5. Preservation of structure on proposed Kroger property

Discussion was had regarding the preservation of the former home of Dr. Myron Allen. The house is located on property soon to be under development by Kroger. The HPC, with support of the DDA, will write a letter to Kroger asking to preserve the historic house, also requesting further conversation about its future. Time is of the essence.

6. Historic Hoschton family storyboards

Mr. Vogt would like to work on a mock-up tri-fold presentation detailing the history of the Hosch family. Ms. Tanner will bring some items to the next meeting to use.
